| Investment Objective | The Company expects that an investment in the New Options will be suitable to investors who wish to gain exposure to equities in a small-cap mining company listed on the Australian Securities Exchange (ASX). |
| Investment Timeframe | <p>The target market of investors will take a short to medium term outlook in relation to their investment. Investors with a short-term outlook for their investment will benefit from an ability to exercise New Options and trade the underlying Shares issued on exercise should the exercise price of the New Options be lower than the trading price of Shares.
